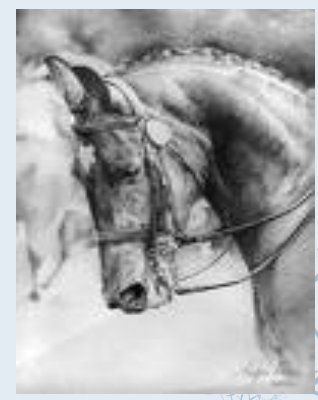

Arenas: 200X60 Indoor show arena with rubber and sand mixture footing.
60X120 sand indoor makeup arena.

Accommodations: Lincoln Lodge (9 miles), Holiday Inn (11 miles), Hilton Garden Inn (11 miles)

Awards: Each class awarded six ribbons. Show Champion & Reserve Champion awarded to all divisions. Series awards to be awarded following the March 6th show. To be eligible for Series Championship Awards, horse & rider combination must show in 3 out of the 4 shows. Awards based on accumulated points: 1st = 6 points, 2nd = 5 points, 3rd = 4 points, 4th = 3 points, 5th = 2 points, 6th = 1 point.

Classes: Current USDF/USEF tests will be used. Shows will be conducted under USEF rules unless otherwise noted by show management. ASTM approved helmets must be worn by all Jr. riders at all times. Sr. riders are strongly suggested to wear ASTM approved helmets. Management has the right to combine or divide classes as needed. Classes will be divided between Jr. & Sr. divisions if entries warrant.

Coggins: Negative Coggins required for all horses within 12 months. Coggins must be presented before horses can be unloaded. Name on Coggins must match name of horse on entry form.
